

## **REMUNERATION TRIBUNAL**

## Determination 2004/24: Remuneration and Allowances for Holders of Public Office

- (i) Pursuant to subsections 7(3) and 7(4) of the Remuneration Tribunal Act 1973, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to various public office holders, and other matters significantly related thereto, and determines as set out below.
- (ii) This Determination takes effect on and from the date of signature except where otherwise specified.

## PART 1 – PART-TIME HOLDERS OF PUBLIC OFFICE

- <sup>1.1</sup> In this part Determination Number 12 of 2004 (as amended) is referred to as the Principal Determination.
- 1.2 **Table A1A of Schedule A** of the Principal Determination is amended by inserting the following entry for the Australian Technology Group immediately following the entry for the 'National Offshore Petroleum Safety Authority' and the following entry for the Financial Reporting Panel following the entry for the 'Military Rehabilitation and Compensation Commission':

- 2.2 **Table 3A (Accommodation Allowances) of Part 3** of the Principal Determination is amended by inserting the following entry:

<sup>2.3</sup> The Principal Determination is amended by inserting a new subclause 3.1.7 after subclause 3.1.6, as follows:

**'3.1.7 Professional Services Review:** Dr Webber is entitled to an accommodation allowance up to the rate specified in Column 3 of Table 3A from 14 February 2005 until 31 December 2006.'

- <sup>2.4</sup> **Table 2A of Part 2** of the Principal Determination is amended by omitting the figures in Columns 2 and 3 against the entry for the 'Australian Electoral Commissioner' and inserting the figures '\$185,470' and '\$250,600' in Columns 2 and 3 respectively.
- 2.5 Clause 2.4 takes effect on and from 10 December 2004.
