### **Determination 2010/02: Remuneration and Allowances for Holders of Public Office**

---

- (i) Pursuant to subsections 7(3) and 7(4) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to holders of public office, and other matters significantly related thereto, and determines as set out below.
- (ii) This Determination takes effect on and from the day following the day it is registered in the Federal Register of Legislative Instruments unless otherwise specified.

#### **PART 1 – PART-TIME OFFICES**

- 1.1** In this part, Determination Number 14 of 2009 (as amended) is referred to as the Principal Determination.
- 1.2** Table A1A of Schedule A of the Principal Determination is amended by replacing “-” with “\$185,350 - *a*” in Column 2 of the entry for “NBN Co Limited”.
- 1.3** Table A1A of Schedule A of the Principal Determination is amended by inserting the following entry after the entry for “CSIRO – Advisory Committees”:



- 1.4** Table A1A of Schedule A of the Principal Determination is amended by inserting the following entry after the entry for “Tourism Australia”:

- 1.5** The Principal Determination is amended by inserting Clause A44 after Clause A43 of the Additional Clauses to Table A1A: "**A44. Australian Institute for Teaching and School Leadership Ltd (AITSL)**: From 1 January 2010 to 31 December 2010, the Chair will receive the Chair's fee plus an additional loading of 50 per cent. From 1 January 2010 to 31 December 2010 the Deputy Chair will receive \$60,000 per annum, plus an additional loading of 50 per cent. The Deputy Chair is entitled to Tier 1 Travel arrangements".
- 1.6** Clauses 1.4 and 1.5 have effect on and from 1 January 2010.
- 1.7** Table A1A of Schedule A of the Principal Determination is amended by deleting the entry for the following body: "Teaching Australia – Australian Institute for Teaching and School Leadership".
- 1.8** The Principal Determination is amended by deleting clause "A14" of the Additional Clauses to Table A1A.
- 1.9** Table A1A of Schedule A of the Principal Determination is amended by replacing the current wording in Column 1 of the entry for "Anti-Doping Rule Violation Panel - Advisory Group" with "ASADA – Advisory Group".


