

## **Determination 2016/02:**

# Remuneration and Allowances for Holders of Public Office and Principal Executive Office

- (i) Pursuant to subsections 7(3) and 7(4) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to certain holders of public office, and other matters significantly related thereto, and determines as set out below.
- (ii) This Determination takes effect on and from the day following the day it is registered on the Federal Register of Legislation unless otherwise specified.

#### **PART 1 - FULL-TIME OFFICES**

- 1.1 In this part, Determination Number 21 of 2015 (as amended) is referred to as the Principal Determination.
- **1.2** Table 2A of Part 2 of the Principal Determination is amended by inserting the following entry after the entry for "Vice President, Fair Work Commission".
